Eligibility

- Has participated in the league in the year of the award (played, umpired or officiated)

Criteria

A person nominated for this award must have demonstrated leadership qualities and characteristics. Examples of leadership qualities include but are not limited to;

- Behaving like a leader to peers on the field during a certain match or incident
- Leadership at the club level through ongoing involvement, either on or off the field
- Showing initiative for programs to encourage participation and sense of community
- Championing a cause to raise awareness or funds of a particular event or issue

- What impact has the nominee's accomplishment had on others?
- Include additional comments
